**APPROVING AND DECLARING OPERATIVE THE SUPPLEMENTAL  
BUDGETS FOR CALENDAR YEAR 2021 OF DIFFERENT BARANGAYS  
OF BATANGAS CITY**

**WHEREAS**, a review of the Supplemental Budgets for Calendar Year 2021 of different Barangays of Batangas City show substantial compliance with the provisions of the Local Government Code of 1991;

**NOW THEREFORE**, be it resolved, as it hereby resolves, to approve and declare operative the Supplemental Budget for Calendar Year 2021 for the purpose the amount was appropriated:
