WHEREAS, in order to better serve the populace and to fully address the needs and demands of the school, the Schools Division Superintendent, Dr. Felizardo O. Bolaños, is requesting the Sangguniang Panlungsod for a resolution to change the name of the said school;

WHEREAS, the name is consistent with Republic Act No. 9155 known as the “Governance of Basic Education Act of 2001 “that the school shall have a single aim of providing the best possible basic education for all learners;

NOW THEREFORE, be it resolved, as it is hereby resolved by the Sangguniang Panlungsod in session assembled to change the name of Batangas National High School to Batangas City Integrated High School.


UNANIMOUSLY APPROVED by the Sangguniang Panlungsod this 27th day of April 2021.”
