These Sangguniang Kabataan budgets are therefore considered operative and effective as of January 1, 2022 in accordance with Section 332 of R.A. 7160.



Certified copy of this resolution shall immediately be furnished to the concerned Sangguniang Kabataan, through the Punong Barangay and to the City Budget Officer.
