**APPROVING AND DECLARING OPERATIVE THE SUPPLEMENTAL BUDGET OF  
DIFFERENT BARANGAYS OF BATANGAS CITY FOR CALENDAR YEAR 2022**

**WHEREAS**, a review of the Supplemental Budget for Calendar Year 2022 of different Barangays shows substantial compliance with the provisions of the Local Government Code of 1991;

**NOW THEREFORE**, be it resolved, as it hereby resolves, to approve and declare operative the Supplemental Budget of different barangays for Calendar Year 2022 for the purpose the amount was appropriated:


