**APPROVING AND DECLARING OPERATIVE THE 2022 SANGGUNIANG
KABATAAN SUPPLEMENTAL BUDGET OF BARANGAY PALLOCAN EAST,
BATANGAS CITY**

WHEREAS, a judicious review, evaluation and analysis of each of the Sangguniang Kabataan Supplemental Budget submitted to the Sangguniang Panlungsod shows substantial compliance with law and all budgetary rules and regulations.

NOW THEREFORE, be it resolved, as it hereby resolves, to approve and declare operative the Sangguniang Kabataan Supplemental Budget for the purpose the amount was appropriated:

RESPONSIBILITY. The execution of the budget and the accountability therefore shall be vested primarily in the Sangguniang Kabataan (SK) Chairman.

Certified copy of this resolution shall immediately be furnished to the Sangguniang Kabataan, through the Punong Barangay and to the City Budget Officer.


