

COMMENTS/RECOMMENDATIONS

The subject request for the passage of an Ordinance was referred to the Committee on Laws, Rules and Regulations for its consideration during the Regular Session on May 04, 2022 while its title and whereas were also approved on the same date.

This Ordinance shall be known and cited as the Batangas City HIV and AIDS Policy Ordinance.

Batangas City recognizes that Human Immunodeficiency Virus (HIV) and Acquired Immune Deficiency Syndrome (AIDS) are public health concerns that have wide-ranging social, political and economic impact that the government has to address issues and incidents related thereto with utmost diligence and anchored on the principles of human rights upholding human dignity.

Considering no legal impediment for the approval of the ordinance and that the said ordinance would be beneficial to the Batangas City government and its constituents, the Committee hereby recommends:


1. The adoption of this Committee Report.
2. The approval of the said Ordinance for Second and Final Reading in today's regular session.


