**APPROVING AND DECLARING OPERATIVE THE SUPPLEMENTAL BUDGET FOR
CY 2022 OF BARANGAY DELA PAZ PULOT ITAAS, BATANGAS CITY**

WHEREAS, a review of the Supplemental Budget for Calendar Year 2022 of Barangay Dela Paz Pulot Itaas, Batangas City shows substantial compliance with the provisions of the Local Government Code of 1991;

NOW THEREFORE, be it resolved, as it hereby resolves, to approve and declare operative the Supplemental Budget of Barangay Dela Paz Pulot Itaas, Batangas City for Calendar Year 2022 for the purpose the amount was appropriated:

Sangguniang Barangay – Supplemental Budget – CY 2022

1. Dela Paz Pulot Itaas Php 607,532.70

RESPONSIBILITY. The execution of the budget and the accountability therefore shall be vested primarily in the Punong Barangay.

COMPLIANCE. Compliance to the provisions of the Budget Operations Manual for LGUs issued by the Department of Budget and Management and Commission on Audit and to all auditing rules and regulations are hereby mandated.


