**APPROVING AND DECLARING OPERATIVE THE SUPPLEMENTAL BUDGET  
NO. 2 OF BARANGAY POBLACION 14, BATANGAS CITY**

**WHEREAS**, a review of the Supplemental Budget No. 2 for Calendar Year 2022 of Barangay Poblacion 14, Batangas City shows substantial compliance with the provisions of the Local Government Code of 1991;

**NOW THEREFORE**, be it resolved, as it hereby resolves, to approve and declare operative the Supplemental Budget No. 2 of Barangay Poblacion 14, Batangas City for Calendar Year 2022 for the purpose the amount was appropriated:
