WHEREAS, a judicious review, evaluation and analysis of the Sangguniang Kabataan Supplemental Budget of Barangay Sorosoro Ilaya, Batangas City submitted to the Sangguniang Panlungsod shows substantial compliance with law and all budgetary rules and regulations.


