RESOLUTION NO. 115 S. 2022

**APPROVING AND DECLARING OPERATIVE THE SUPPLEMENTAL BUDGET OF
DIFFERENT BARANGAYS OF BATANGAS CITY**

WHEREAS, a review of the Supplemental Budget for Calendar Year 2022 of different Barangays shows substantial compliance with the provisions of the Local Government Code of 1991;

NOW THEREFORE, be it resolved, as it hereby resolves, to approve and declare operative the Supplemental Budget of different barangays for Calendar Year 2022 for the purpose the amounts were appropriated:

Sangguniang Barangay – Supplemental Budget – CY 2022

1. Banaba West	PHP 120,000.00
2. Dela Paz Proper	733,946.92
3. Sorosoro Ilaya	1,099,244.38

RESPONSIBILITY. The execution of the budget and the accountability therefore shall be vested primarily in the Punong Barangay.

COMPLIANCE. Compliance to the provisions of the Budget Operations Manual for LGUs issued by the Department of Budget and Management and Commission on Audit and to all auditing rules and regulations are hereby mandated.


