RESOLUTION NO. 117 S. 2022

APPROVING ON FIRST READING AND REFERRING TO THE COMMITTEE ON LAWS, RULES AND REGULATIONS THE PROPOSED ORDINANCE MANDATING THE INSTALLATION OF CLOSED CIRCUIT TELEVISION (CCTV) OR VIDEO SURVEILLANCE SYSTEM AS A STRICT REQUIREMENT PRIOR TO THE OPENING OF BUSINESS ESTABLISHMENTS AND IN THE RENEWAL OF ALL BUSINESS PERMITS IN THE CITY OF BATANGAS WHICH SHALL ALSO INCLUDE BARANGAY BUILDINGS AND OTHER HIGH RISK PUBLIC STRUCTURES AND PREMISES, PROVIDING PENALTIES FOR VIOLATION THEREOF

RESOLVED, to approve on First Reading and to refer to the Committee on Laws, Rules and Regulations for study, comments and recommendation the proposed ordinance entitled: “An Ordinance Mandating the Installation of Closed Circuit Television (CCTV) or Video Surveillance System as a Strict Requirement Prior to the Opening of Business Establishments and in the Renewal of All Business Permits in the City of Batangas Which Shall Also Include Barangay Buildings and Other High Risk Public Structures and Premises, Providing Penalties for Violation Thereof”.


