RESOLUTION NO. 121 S. 2022

**APPROVING AND DECLARING OPERATIVE THE SUPPLEMENTAL BUDGETS OF
BARANGAY POBLACION 8 AND BANABA EAST, BOTH OF BATANGAS CITY**

WHEREAS, a review of the Supplemental Budgets for Calendar Year 2022 of Barangay Poblacion 8 and Banaba East, both of Batangas City shows substantial compliance with the provisions of the Local Government Code of 1991;

NOW THEREFORE, be it resolved, as it hereby resolves, to approve and declare operative the Supplemental Budgets of Barangay Poblacion 8 and Banaba East, both of Batangas City for Calendar Year 2022 for the purpose the amounts were appropriated:

Sangguniang Barangay – Supplemental Budget – CY 2022

1. Poblacion 8	Php	20,000.00
2. Banaba East		347,438.19

RESPONSIBILITY. The execution of the budget and the accountability therefore shall be vested primarily in the Punong Barangay.

COMPLIANCE. Compliance to the provisions of the Budget Operations Manual for LGUs issued by the Department of Budget and Management and Commission on Audit and to all auditing rules and regulations are hereby mandated.

APPROVING AND DECLARING OPERATIVE THE SUPPLEMENTAL BUDGETS OF BARANGAY POBLACION 8 AND BANABA EAST, BOTH OF BATANGAS CITY

EFFECTIVITY. The approved Supplemental Budget of different barangays shall take effect upon approval by the Sangguniang Barangay concerned or on the date fixed in the Barangay Ordinance as provided in Article 416 IRR and Section 332 LGC.
