

COMMITTEE REPORT

TO: The Presiding Officer and Members Sangguniang Panlungsod Batangas City

FROM: The Committee of the Whole chaired by the:
Committee on Environment, Urban Development, Land Use and Zoning

SUBJECTS: 1. Application for Zoning/Locational Clearance of SURI Waste Management and Disposal Services, Inc. for a Proposed Sanitary Landfill Facility with an area of 7.537 hectares located in Brgy. San Jose Sico, Batangas City;

2. Request for a "Resolution of No Objection" for the proposed Sanitary Landfill Facility

The Joint Committees held a hearing on the subject Application on June 23, 2022.

The applicant, SURI Waste Management and Disposal Services Incorporated, is a waste management company with main business office at NIA Road, Brgy. Niugan, Cabuyao City, Laguna. It has acquired a 31-hectare property in Sitio Catmon, Brgy. San Jose Sico, Batangas City and proposes to develop an engineered sanitary landfill with provisions of treatment, storage, and disposal facilities for healthcare wastes and other refuse materials.

Of the 31 hectares of property, 7.537 is already within the Utilities, Transportation, and Services Zone per the Batangas City Integrated Zoning Ordinance of 2019, while the remaining portion with the area of 23.5 hectares is classified under the same Zoning Ordinance as Production Agricultural Sub-Zone. The Sangguniang Barangay of San Jose Sico granted the applicant an approval for the proposed sanitary landfill project through Resolution No. 11 Series of 2022, and a Barangay Clearance interposing no objection to the project was subsequently issued. The applicant has also secured an Environmental Compliance Certificate from the EMB-DENR.

The proposed project shall include segregation/sorting facility, materials recovery facilities, sanitary landfill cells regardless of capacity, administrative office, composting facility, guard house, leachate collection pond, comfort room, road/access system, parking area, and other related support facilities. The proposed project is expected to provide employment and economic gains for the host barangay.

The Applicant Company commits to adhere and strictly comply with pertinent environmental laws and local ordinances.

Considering the foregoing findings, the Joint Committees find no reason to object to the proposed project.

The recommendations of the City Planning and Development Office in its Evaluation Report on the subject application is adopted by the Joint Committees.

Lastly, there is a need to create a Multipartite Monitoring Team composed of the different stakeholders, key government agencies such as, but not limited to DENR/City ENRO, and CHO, and the host Barangay, to ensure the health, safety, and general welfare of the affected community.

RECOMMENDATIONS:

1. The approval of the Application for Zoning/Locational Clearance of SURI Waste Management and Disposal Services, Inc. for a Proposed Sanitary Landfill Facility with an area of 7.537 hectares located in Brgy. San Jose Sico, Batangas City, subject to compliance with the conditions stated in the Evaluation Report of the City Planning and Development Office attached as Annex "A"; and subject to the creation of a Multipartite Monitoring Team as aforementioned.
2. The approval of a Resolution of No Objection in favor of the proposed sanitary landfill project of SURI Waste Management and Disposal Services, Inc.; and
3. The adoption of this Committee Report.






