**APPROVING AND DECLARING OPERATIVE THE 2022 SANGGUNIANG
KABATAAN SUPPLEMENTAL BUDGET OF BARANGAY SAN AGAPITO,
ISLA VERDE, BATANGAS CITY**

WHEREAS, a judicious review, evaluation and analysis of the Sangguniang Kabataan Supplemental Budget of Barangay San Agapito, Isla Verde, Batangas City submitted to the Sangguniang Panlungsod shows substantial compliance with law and all budgetary rules and regulations.

NOW THEREFORE, be it resolved, as it hereby resolves, to approve and declare operative the Sangguniang Kabataan Supplemental Budget of Barangay San Agapito, Isla Verde, Batangas City for the purpose the amount was appropriated:
