**APPROVING AND DECLARING OPERATIVE THE SUPPLEMENTAL BUDGET
OF BARANGAY STA. RITA APLAYA, BATANGAS CITY**

WHEREAS, a review of the Supplemental Budget for Calendar Year 2022 of Barangay Sta. Rita Aplaya, Batangas City shows substantial compliance with the provisions of the Local Government Code of 1991;

NOW THEREFORE, be it resolved, as it hereby resolves, to approve and declare operative the Supplemental Budget of Barangay Sta. Rita Aplaya, Batangas City for Calendar Year 2022 for the purpose the amount was appropriated:

RESPONSIBILITY. The execution of the budget and the accountability therefore shall be vested primarily in the Punong Barangay.
