AS AMENDED BY SEC. 6 OF R.A. 9257 OTHERWISE KNOWN AS THE EXPANDED  
SENIOR CITIZENS ACT OF 2003**

**WHEREAS**, Article One (1) Sec. 455 Par. (1) subpar (v) of R.A. 7160 provides that, the City Mayor has the power to appoint all officials..., as well as those may be authorized by law;

**WHEREAS**, Section 6 of R.A. 7432 as amended by R.A. 9257, otherwise known as The Expanded Senior Citizens Act of 2003 provides that... there shall be established in all cities, an Office of the Senior Citizens Affair (OSCA) to be headed by a senior citizen who shall be appointed by the City Mayor for three (3) years without reappointment;

**WHEREAS**, among the list of three (3) nominees chosen among the Representatives from 86 Barangays and endorsed to the Sangguniang Panlungsod, Mrs. Josefina E. Dangal is the best and foremost choice of the City Mayor to be appointed as the new Chairperson of the Office of Senior Citizens Affair (OSCA) replacing the current Chairperson Flordeliza Antenor who is to end her tenure soon;

**WHEREAS**, Mrs. Josefina E. Dangal of Barangay Poblacion 8 of this City is a person of moral values, humility, integrity, compassion and the most qualified to lead the Senior Citizens welfare and development. Hence, the Committee highly believes she is the rightful person to head the Office of Senior Citizens Affair (OSCA);

Sir/Mesdames:

Referred to the Committee on Senior Citizens and Persons with Disabilities is the aforementioned subject which was discussed and officially given pronouncement. The hearing was held on July 19, 2022, 10am, at the Sangguniang Panlungsod Session Hall.

Present during the hearing were the Chairman of the Committee on Senior Citizens and Persons with Disabilities, Hon. Coun. Nestor E. Dimacuha and Members, Hon. Coun. Isidra M. Atienza, Hon. Coun. Jonash F. Tolentino, Hon. Coun. Hamilton G. Blanco, and Hon. Coun. Zester M. Hernandez. Also present were the Sangguniang Panlungsod Presiding Officer, Hon. Vice Mayor Atty. Alyssa Renee A. Cruz – Atienza, Hon. Coun. Karlos Emmanjuel A. Buted, Hon. Coun. Andrea F. Macaraig, Hon. Coun. Oliver Z. Macatangay, Hon. Coun. Amando C. Lazarte, Hon. Coun. Nelson J. Chavez, Hon. Coun. Lorenzo A. Gamboa , Hon. Coun. Michael C. Villena, ABC President Hon. Angelito Dondon A. Dimacuha, SK President Hon. Marjorie Manalo, the newly appointed OSCA Chairperson Mrs. Josefina F. Dangal, the outgoing OSCA Chairperson, Mrs. Flordeliza Antenor, the Senior Citizens Board of Directors, Mr. Benigno Faral, Mr. Alberto G. Burog, Mrs. Virginia C. Clemeno, Mrs. Beatriz Q. Untalan, Mr. Apolonio B. Santoyo, Doctor for Senior Citizens, Dr. Mulsid, and CSWDO Representative Mrs. Hiyasmin Candava.

Criteria for the selection of qualified OSCA Chairperson were discussed by CSWDO Representative Mrs. Hiyasmin Candava which include family background, Performance, Leadership and Skills, Educational Background, Values, Voluntary Participation and Financial Capability. Thus, Mrs. Josefina E. Dangal is the most qualified for the position as per evaluation and assessment procedure conducted.

During the hearing, OSCA Chairperson Mrs. Josefina E. Dangal specifies her desired plans, projects, and goals for the development and benefits of Senior Citizens of Batangas City. Important concerns were raised such as expedite processing of Senior Citizens ID and the selection process to be an eligible recipient of Five Hundred Pesos (₱500) monthly Social Pension, whereby there must be proper coordination and collaboration between Board of Directors of Senior Citizens, CSWDO, and the Barangay to make sure that benefits are given to deserving Senior Citizens. In view of this, it was mentioned during the hearing that Senator Joel Villanueva is working on legislative measures proposing additional pension benefits for Senior Citizens.

It was also suggested to craft a comprehensive ordinance or resolution that would strengthen and empower Senior Citizens who have the ability to work, give them expanded care, protection, benefits and privileges that will uplift their integrity and confidence that they are important part of our community.


