# RESOLUTION URGING BARANGAY COUNCILS OF BATANGAS CITY TO INITIATE AND INSTITUTE THE REGISTRATION AND FORM A DATABASE OF ALL OVERSEAS FILIPINO WORKERS (OFWs) IN THEIR RESPECTIVE BARANGAYS

WHEREAS, for Filipinos, being an OFW is a promise of a good life, where they earn more working outside of the Philippines and are able to provide a better life for families back home;

WHEREAS, they are modern-day heroes because they experience all kinds of hardship, physical, mental, social and emotional as they work overseas for their families and face different challenges like homesickness and cultural differences;

WHEREAS, OFWs belong to an important sector of the country because of their economic contribution through their remittances that helped a lot in keeping the country's economy afloat;

WHEREAS, despite the big role being played by our OFWs in the country, it has been observed that there seems to be an inaccurate data on the number of OFWs as provided by the Philippine Overseas Employment Agency (POEA), Overseas Workers and Welfare Administration (OWWA), and the Commission on Filipino Overseas (CFO);

WHEREAS, according to studies maintaining a database is proven to be an effective method of providing an organized and systematic recording of information that can be easily accessed, managed, and updated;
