RESOLUTION NO. 22-180 S. 2022

A RESOLUTION EMPHASIZING THE IMPLEMENTATION OF ORDINANCE NO. 11 S. 1998 AS BASIS FOR STRATEGIC PREPARATION AND DENGUE CASES PREVENTION FOR THE OPENING OF SCHOOL YEAR 2022-2023 AND RESUMPTION OF FIVE DAYS IN-PERSON CLASSES AND FOR OTHER PURPOSES

WHEREAS, Ordinance No. 11 S. 1998, otherwise known as "An Ordinance Instituting the Month of September as Dengue Awareness Month in Batangas City and Prescribing the Duties and Functions of the Department of Education, Culture and Sports in Batangas City and the City Health Office of the Effective Implementation Thereof", was enacted in September 21, 1998 and was approved by the City Mayor in September 30, 1998 with the prime purpose of inculcating in the minds of the citizens that Dengue disease is a concern of everyone and that its elimination lies solely on full cooperation and coordinated efforts of the government and its citizenry;

WHEREAS, DepEd Order No. 034 S. 2022 states that the School Year 2022-2023 shall formally open on August 22, 2022 and shall consist of 203 school days or as may be determined by further issuance(s) in case of changes in the school calendar due to unforeseen circumstances; and shall conduct Brigada Eskwela and Oplan Balik Eskwela focusing in information campaigns and strengthening partnerships that complement the Department's effort to ensure quality basic education;

WHEREAS, the Department of Health announced fifteen (15) regions have recorded dengue fever cases in January to June 2022 exceeding the epidemic threshold or an equivalent of eighty-three per cent (83%) higher than 2021 data and 745 cases were from the Batangas Province;

WHEREAS, the incoming school year opening and the resumption of five days in-person classes, the execution of DepEd's Brigada Eskwela and Oplan Balik Eskwela, and the nearing month of September as Dengue Awareness Month, coincide as vital consideration in emphasizing the provisions of Ordinance No. 11 S. 1998: its objectives, scope, enjoined duties and responsibilities of stakeholders involved;

NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED by the Sangguniang Panlungsod in session assembled, to emphasize the implementation of Ordinance No. 11 S. 1998 as basis for strategic preparation and Dengue cases prevention for the opening of School Year 2022-2023 and resumption of five days in-person classes and for other purposes;

RESOLVED FURTHER, to reiterate the implementation of DOH's 4S Anti-Dengue Advocacy Campaign and its inclusion in information dissemination and education programs in the holding of DepEd's Brigada Eskwela and Oplan Balik Eskwela;

RESOLVED FINALLY, to furnish a copy of this Resolution to the City Health Office and the Batangas City Schools Division Superintendent of the Department of Education for guidance and perusal.
