**APPROVING AND DECLARING OPERATIVE THE SUPPLEMENTAL BUDGETS
FOR CY 2022 OF BARANGAYS BALETE AND BANABA CENTER, BOTH OF
BATANGAS CITY**

WHEREAS, a review of the Supplemental Budgets for Calendar Year 2022 of Barangays Balete and Banaba Center, both of Batangas City shows substantial compliance with the provisions of the Local Government Code of 1991;

NOW THEREFORE, be it resolved, as it hereby resolves, to approve and declare operative the Supplemental Budgets of Barangays Balete and Banaba Center, both of Batangas City for Calendar Year 2022 for the purpose the amounts were appropriated:

Sangguniang Barangay – Supplemental Budget – CY 2022

1. Balete	Php	1,163,000.47
2. Banaba Center		209,645.00

RESPONSIBILITY. The execution of the budget and the accountability therefore shall be vested primarily in the Punong Barangay.


