**RESOLUTION NO. 22-210 S. 2022**

**RESOLUTION OF SUPPORT AND ADMIRATION TO THE FIRST  
SINE BATANGAN FILM FESTIVAL**

**WHEREAS**, Article III, Section 17 of the 1987 Constitution provides that: "The State shall give priority to education, science and technology, arts, culture, and sports to foster patriotism and nationalism, accelerate social progress, and promote total human liberation and development"; while Article XIV, Section 14 thereof provides that: "The State shall foster the preservation, enrichment and dynamic evolution of a Filipino national culture based on the principle of unity in diversity in a climate of free artistic and intellectual expression";

**WHEREAS**, Section 16 or the General Welfare Clause of the Republic Act No. 7160 - Local Government Code so provides: "...Within their respective territorial jurisdictions, local government units shall ensure and support, among other things, *the preservation and enrichment of culture*, promote health and safety, enhance the right of the people to a balanced ecology, encourage and support the development of appropriate and self-reliant scientific and technological capabilities, improve public morals and enhance economic prosperity and social justice, promote full employment among their residents, maintain peace and order, and preserve the comfort and convenience of their inhabitants";

**WHEREAS**, the first Sine Batangan Film Festival was held on September 18-25, 2021 through social media to further advance the causes of the Batangueño cultural heritage, history and traditions;
