RESOLUTION AUTHORIZING THE CITY MAYOR TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD) - FIELD OFFICE FOR THE IMPLEMENTATION OF SUPPLEMENTAL FEEDING PROGRAM

WHEREAS, the Supplementary Feeding Program (SFP) is the provision of food in addition to the regular meals to target children ages 2-5 years old enrolled in the Child Development Center (CDCs) and Supervised Neighborhood Play (SNPs) as part of the DSWD's contribution to the early childhood care and development (ECCD) program of the government;

WHEREAS, Section 4 (v) sub-item (8) of R.A. No. 11469 otherwise known as the "Bayanihan to Heal As One Act" has identified the SFP as one of the priority programs necessary or beneficial in order to address COVID-19 emergency;

WHEREAS, local government units (LGUs), as partners of the DSWD in the expeditious delivery of the social amelioration program, shall also assist in the implementation of SFP;

WHEREAS, fund transfer to LGUs is identified as the best scheme to fast track the implementation of the program to the beneficiaries, and shall be an interim solution for the current emergency or crisis situation due to COVID-19;
