## THE COMMITTEE ON APPROPRIATIONS

### COMMITTEE REPORT

*Requesting the Passage of a Resolution Approving the Purchase of Different Vehicles*

#### BACKGROUND:

The subject is a Letter from the City Mayor Beverley Rose A. Dimacuha Requesting the Passage of a Resolution Approving the Purchase of Different Vehicles. This was referred to the Committee on Appropriations for its consideration during the Regular Session last August 9, 2022. The Committee held a hearing on August 15, 2022 and in attendance were the following:

Vice Mayor Atty. Alyssa Renee A. Cruz; Members of the committee, chaired by Vice Chariman Hon. Nestor E. Dimacuha, and its members: Hon. Isidra M. Atienza, Hon. Lorenzo A. Gamboa, Jr., and Hon. Nelson J. Chavez. Also present were Sangguniang Panlungsod Members: Hon. Andrea F. Macaraig, Hon. Armando Lazarte, Hon. Dr. Jonash Tolentino, Hon. Zester Hernandez, Hon. Michael Villena, and SK Federation President Hon. Marjorie A. Manalo. City Treasurer Ms. Arminda Madayag, City Budget OIC Mr. Manolo Perlada, and Ms. Sherryl Bool from the City Accounting Office, and General Services Officer Ms. Joyce Cantre were also present.

#### FINDINGS:

The Chairman of the Committee on Appropriations, the members of the Committee, and Members of the Sangguniang Panlungsod briefly made an overview of the subject and suggested necessary matters:

1. Ms. Joyce Cantre from the General Services Department mentioned that the purchase of the vehicles is valid and is part of the Annual Investment Plan;
2. City Treasurer Ms. Arminda Madayag stated that there is available fund; and
3. Below is the itemized list and specifications of the various vehicles to be purchased:

*4 cylinders*

*1,766,000 x 3 = 5,298,000.00*


