PUBLIC HEARING ON THE PUBLIC CONSULTATION REGARDING THE LEGISLATIVE AGENDA

COMMENTS/RECOMMENDATIONS

- To adopt and approve this Committee Report and the Resolution hereto attached as the Legislative Agenda of the Sangguniang Panlungsod ng Batangas including the Annexes prescribed.
- 4. To furnish copies of this Resolution to the Office of the Mayor and other concerned offices, departments and agencies for their information, guidance and reference.
