WHEREAS, Sec. 18 of RA 7160, otherwise known as the Local Government Code of the Philippines, provides that local government units shall have the power and authority to establish an organization that shall be responsible for the efficient and effective implementation of their development plans, program objectives and priorities;

WHEREAS, Section 458(1) of RA 7160, otherwise known as the Local Government Code of 1991, provides that "the Sangguniang Panlungsod, as the legislative body of the city, shall enact ordinances and approve resolutions necessary for efficient and effective government";

WHEREAS, Section 458(2) of the same law states that the Sangguniang Panlungsod, as the legislative body of the city, shall "Generate and maximize the use of resources and revenues for the development plans, program objectives and priorities of the city as provided for under Section 18 of this Code, with particular attention to agro-industrial development and city-wide growth and progress,";

WHEREAS, the Executive-Legislative Agenda (ELA) is a term-based strategic planning document that is mutually developed and agreed upon by both the executive and legislative departments of a local government unit in consultation with various stakeholders in its various stages, initially from needs identification to plan implementation, monitoring and evaluation;

WHEREAS, as a method, the formulation of the Executive-Legislative Agenda (ELA) includes the constituents of the Local Government Unit that will enable ELA to deliver avenues for empowerment and consensus among diverse stakeholders in pursuing a set of consolidated action designed for the purpose of realizing desired development and advancement in the local community;

WHEREAS, the ELA is comprised of Two Primary Fundamental Elements specifically: 1. Executive Agenda and 2. Legislative Agenda;

WHEREAS, prior to the 19th of August 2022, the Sangguniang Panlungsod conducted an Access To Empowerment initiative wherein Civic Society Organizations were empowered to craft, formulate and submit proposals for legislative measures that shall be responsive to the goals, objectives, and advocacy of the sectors they duly represent;

WHEREAS, on 19th of August 2022, the Sangguniang Panlungsod of Batangas conducted a Capacity Development Enhancement Initiave through a Public Hearing wherein the representatives and delegates from various multi-sectoral civic organizations were invited to present and discuss their submitted proposal;

WHEREAS, on 19th of August 2022, the Members of the Sangguniang Panlungsod, crafted and formulated the Legislative Agenda of the Sangguniang Panlungsod of Batangas for the term 2022-2025, comprised of (1) legislative measure proposals from the multi-sectoral civic society organizations and (2) legislative measure proposals of Vice Mayor Alyssa Renee A. Cruz and Sangguniang Panlungsod members responsive to the Eight (8) Point Agenda of the City Mayor Beverley Rose Abaya Dimacuha that was deemed by the Sangguniang Panlungsod to be an integral part of the Legislative Agenda;

WHEREAS, the formulated Legislative Agenda attached hereto as "Annex A and B", focuses on the important sectors of development particularly infrastructure, good governance, public safety and welfare, health, education, economic, food security and environmental developments;

WHEREAS, after thorough discussion and deliberation, the Sangguniang Panlungsod of Batangas deems it necessary to adopt the proposed hereto attached Legislative Agenda of the Sangguniang Panlungsod of Batangas for the period of 2022 to 2025 as an integral part of this Resolution;

AGENDA THRUSTING EXPANDED SOCIAL PROGRAMS: Equal and Equitable Access of Social Services

Ideal social programs that promotes welfare can be in form of public or free education, healthcare management and system, sanitation and disease prevention, and employment opportunities. Equal and equitable access to social services is an indicator of public satisfaction as each individual or group of people receives government support regardless of social, economic, demographic, and geographic differences. The provision of same resources or opportunities or equality must recognize that each component of the society has its own different circumstances, thus, equitable allocation of exact resources and opportunities need to reach an equal outcome.

Agenda No. 4
ADVANCEMENT TOWARDS ECONOMIC STIMULUS AND CONSUMER WELFARE
PROTECTION: Local Economic Policies for SMEs

Micro, small and medium enterprises (MSMEs) plays a significant role in developing local economy. Level of poverty is reduced in the creation of jobs for the City's increasing labor force. This stimulates local economic development and eventually impacts on a wider scope. Being an important sector in the developing urban City of Batangas, issues such as inadequacy of business operations, constraints in human resources, compliance difficulties with national standards and government regulations, lack of access to finance, lack of access to market and marketing knowledge, and uncertain consumer preference prevents MSMEs to achieve sustained productivity.

Agenda No. 5
AIMS TOWARDS ERADICATING INFORMAL SETTLEMENTS: Comprehensive Socialized Housing Initiatives

A developing city is not exempted from the problems caused by the growing number of informal settlements as this is a global concern associated with urban population growth. Informal settlements is connected with rural-to-urban migration, lack of affordable housing programs, vulnerable local economy, and the lack of comprehensive and responsive public policy in planning and urban management.

Innovation as ideas that constantly surface and technology as both tangible and intangible manifestation of innovative ideas are complementing drivers of growth and prosperity. The advent of modernity transforms technology and innovation as a sophisticated form and measure of competitiveness. Through responsive and strategic enactment of government policies and execution of government programs, producers of technologies and practitioners of innovation can be harmonized in the form of cooperative research undertakings between universities and private companies bridged by government sector.

Agenda No. 7

APPROACHES AND TACTICS FOR EMERGENCIES AND DISASTERS: Receptive Response to Nature-related Crises

Extreme weather conditions brought by the phenomenon of climate change directly increase the number and severity of disasters. Having the weight of people and population concentration in the city as a growing urban area, the geographical and topographical feature of the city that puts areas in high-risk level of flooding, landslide, storm surge, and volcanic eruptions all calls for resilient and receptive measures. As climate change is viewed to be a factor that heightens risk vis-à-vis a nature-caused process leading to build-up of disaster risk, public order and safety is destabilized. This is a threat of inevitable political instability if not resolved with mitigating responses.

Proposed Legislative Measures:

- Committee Hearings for: the feasibility of augmenting fund appropriation for construction and rehabilitation drainage and canal system;
- Ordinance: mandating disaster resilient social infrastructures and providing penalties for violations thereof; institutionalizing the geotagging of critical infrastructures for disaster risk reduction and management information system in Batangas City; institutionalizing Department of City Disaster Risk Reduction Office; comprehensive drainage system and waterways; establishing a command center for centralized dispatch of response in emergencies; and
- Others: passage of a resolution adopting the City Local Shelter Plan

Agenda No. 8

ADAPTIVE AND TRANSFORMATIVE ENVIRONMENT PROTECTION AND PRESERVATION: Sustainable Environment Management

Synchronized approaches are essential for resolving the main environmental and sustainability problems fronting the developing as well as developed cities and communities. With this, a better understanding of the multidisciplinary interrelationships

between environment and sustainable development is a necessity. With the increasing population in Batangas City, the demand for unsustainable energy use, farming and manufacturing activities and carbon footprints increase. The concept of environmental sustainable management is important as reflected by the amount of energy, food and human resources every individual use on a daily basis.

Proposed Legislative Measures:

- Others: review and revision of Batangas City E-Code
