**APPROVING AND DECLARING OPERATIVE THE 2022 SANGGUNIANG
KABATAAN SUPPLEMENTAL BUDGET OF BARANGAY ILIJAN, BATANGAS CITY**

WHEREAS, a judicious review, evaluation and analysis of the Sangguniang Kabataan Supplemental Budget of Barangay Ilijan, Batangas City submitted to the Sangguniang Panlungsod shows substantial compliance with law and all budgetary rules and regulations.
