**WHEREAS**, presented for consideration, legislative review and authorization of the Sangguniang Panlungsod is the Executive Agenda dated August 23, 2022 authorizing the City Mayor, Honorable Beverley Rose A. Dimacuha to represent the City Government of Batangas to enter into and sign the Memorandum of Agreement with the Department of Agriculture (DA) represented by Secretary Hon. Ferdinand R. Marcos Jr. to participate in Philippine Rural Development Project (PRDP) as direct implementer of sub-projects under the components of value chain infrastructure support and rural agri-fishery enterprise and productivity enhancement;

**WHEREAS**, Republic Act 8435, otherwise known as the Agriculture and Fisheries Modernization Act (AFMA) of 1997 sets out the government policies in the agriculture sector in attaining the equitable distribution of opportunities, income and wealth, expanding productivity and sustaining increase in production of goods and services thereby raising the quality of life of the people, especially the underprivileged;

**WHEREAS**, the Department of Agriculture gives a foremost consideration to poverty alleviation and social equity through the development and implementation of the programs and projects that provide the poor sections of the community especially those engaged in subsistence agriculture with equitable access to resources income opportunities, support services and most especially rural infrastructures particularly in areas where productivity is low and the incidence of poverty is high;

**WHEREAS**, the City Government of Batangas manifested its interest to participate in the Philippine Development Rural Project;

**WHEREAS**, in compliance with Section 22 and 444 (b) (1) (vi) of Republic Act No. 7160, the local chief executive is mandated to prepare the contracts she intends to negotiate and enter into in behalf of the city government which are to be submitted to the Sangguniang Panlungsod for legislative authorization and review the executive proposal prior to the adoption of appropriate resolution;

**WHEREAS**, in the exercise of corporate powers of the city, it is required by law that no agreement may be entered into by the Local Chief Executive in behalf of the City Government without prior authorization by the Sangguniang Panlungsod in compliance with Rule IX, Articles 46 and 47 of the Rules and Regulations Implementing the Local Government Code of 1991;

**NOW THEREFORE**, be it resolved as it is hereby resolves by the Sangguniang Panlungsod of Batangas City, in session assembled, to authorize the Local Chief Executive, Honorable Beverley Rose A. Dimaculia to enter into and sign the Memorandum of Agreement (MOA) with the Department of Agriculture (DA) represented by Secretary Hon. Ferdinand R. Marcos Jr. to participate in the Philippine Rural Development Project (PRDP) as direct implementer of sub-projects under the components of value chain infrastructure support and rural agri-fishery enterprises and productivity enhancement;

**RESOLVED FURTHER**, that for all intents and purposes, the agreement to be entered into by the City Government of Batangas with the Department of Agriculture (DA) shall be considered ratified by the legislative body provided that the legible, final copy of such agreement is appended hereto as an integral part of this resolution duly furnished to the Sangguniang Panlungsod City Secretary who shall cause the posting of legible copy of such agreement together with the resolution in the bulletin board at the entrance of the city hall and in at least two (2) other conspicuous places of the city in compliance with Sections 22 and 59 of Republic Act 7160 for proper legislative tracking, monitoring and analysis of implementation;
