Honorables:

Referred to the Committee on Ethics and Good Governance is the aforementioned subject to which the undersigned is reporting to this honorable august body the result of the proceedings.

A committee hearing was held on August 2, 2022 at the Session Hall of the Sangguniang Panlungsod. In attendance were the Committee Chairman Coun. Oliver Macatangay and its members namely: Coun. Michael Villena, Coun. Jose Jonash Luis Tolentino, Coun. Nestor Dimacuha and Coun. Zester Carlo Hernandez. Also present were the Sangguniang Panlungsod Presiding Officer City Vice Mayor Atty. Alyssa Renee A. Cruz and other Sangguniang Panlungsod members namely: Coun. Hamilton G. Blanco, Coun. Andrea Loise F. Macaraig, Coun. Karlos Emmanjuel A. Buted, Coun. Armando Lazarte, Coun. Nelson J. Chavez, Coun. Isidra "Ched" M. Atienza, Coun. Lorenzo "Junjun" Gamboa and ABC President Angelito "Dondon" A. Dimacuha. The complainants Cesar Ypez, and Fidel De Castro and the respondent, Barangay Captain Enrique Cleofe occumpanied by Mr. Serafin Dimaano, Mr. Maximo Celso and Barangay Secretary Myla Maralit of Barangay Kumintang Ibaba, Batangas City were also present.

Considering the length of time of this unresolved case, complainants realized that they are no longer interested to pursue the abovementioned case. Therefore, Mr. Cesar Ypez and Mr. Fidel De Castro manifested their withdrawal from the administrative case filed against Barangay Captain Enrique Cleofe.

The Committee on Ethics and Good Government required the submission of **AFFIDAVIT OF DESISTANCE** to formally DISMISS the Administrative Case of Mr. Cesar Ypez and Mr. Fidel De Castro including Mrs. Maricel Legion against Barangay Captain Enrique Cleofe of Barangay Kumintang Ibaba, Batangas City. The complainants submitted the attached compliance. (Affidavit of Desistance)

Considering the justifications presented above, the committee hereby recommends:

2. The approval of the Affidavit of Desistance hereto attached.




AFFIDAVIT OF DESISTANCE


