Honorables:

The afore-captioned Administrative Case was referred to the Committee on Ethics and Good Government on July 14, 2022. The Committee required the respondent to submit his verified answer before the Committee could commence the formal investigation and hearing of the case.

The respondent Barangay Chairman submitted his verified answer on August 10, 2022 hence the Committee scheduled a hearing on August 31, 2022 at 9:00 in the morning at Sangguniang Panlungsod Session Hall.

However, today, August 30, 2022, the Complainant, Romulo Maranan submitted the attached letter manifesting his willingness to withdraw his complaint on the condition that the Barangay Chairman will act with dispatch on the subject of his complaint, that is, the removal of the portion of the structures which encroached on his property. The letter shows that the complainant and the respondent Barangay Chairman has reaches a certain point of amicable settlement, although conditioned on the immediate favorable action of the respondent.

The subject matter raised in the complaint involves a third party, who is the owner of the allegedly encroaching structures, thus the proper procedure coursed through the City

Government authorities must necessarily be observed. This will ensure that due process will be afforded to everyone concerned.

- Considering the foregoing, the Committee hereby resolves to:

1. Cancel the hearing on the case scheduled tomorrow, August 31, 2022
2. Require the respondent Barangay Chairman to submit within Thirty (30) days to the Committee a Status Report stating the status of his compliance with the condition given by the complainant for the withdrawal of the Administrative Case
3. The Committee on Ethics and Good Government shall render its Report and Resolution on the Case after the respondent has submitted his Status Report as required.




