### COMMITTEE REPORT

*Requesting the Approval of a Resolution Regarding the CY 2022 Supplemental Local Disaster Risk Reduction and Management Investment Program (LDRRMIP)*

#### BACKGROUND:

The subject is a Letter from the City Mayor Beverley Rose A. Dimacuha Requesting the Approval of a Resolution Regarding the CY 2022 Supplemental Local Disaster Risk Reduction and Management Investment Program (LDRRMIP). This was referred to the Committee on Appropriations for its consideration during the Regular Session last August 9, 2022. The Committee held a hearing on August 30, 2022 and in attendance were the following:

Vice Mayor Atty. Alyssa Renee A. Cruz; Members of the committee, chaired by Hon. Karlos A. Buted, and its members: Hon. Lorenzo A. Gamboa, Jr. and Hon. Nelson J. Chavez. Also present were Sangguniang Panlungsod Members: Hon. Andrea F. Macaraig, Hon. Zester Hernandez, SK Federation President Hon. Marjorie A. Manalo. City Treasurer Ms. Arminda Madayag, City Budget OIC Mr. Manolo Perlada, and Ms. Sherryl Bool from the City Accounting Office, CPD Coordinator Ms. Gilda Godoy, and a representative from CDRRMO, Ms. Francine Eje were also present.

#### FINDINGS:

The Chairman of the Committee on Appropriations, the members of the Committee, and Members of the Sangguniang Panlungsod briefly made an overview of the subject and suggested necessary matters:

1. As remarked by Ms. Sheryll Bool from the City Accounting Office, the Supplemental Budget is already approved; however, the LDRRMIP is integrated to the Trust Fund last 2019;
2. Below is the itemized list and corresponding amount indicated in the CY 2022 Supplemental Local Disaster Risk Reduction and Management Investment Program (LDRRMIP) to be charged to the LDRRM Trust Fund for 2022:

a. MOOE	Php 1,300,000.00
b. <u>Capital Outlays</u>	<u>Php 7,800,000.00</u>
<b>TOTAL</b>	<b>Php 9,100,000.00</b>
