WHEREAS, Universal Power Solution, Inc. applied for Zoning/Locational Clearance for the Proposed Integrated Renewable Power Facility Hub Project to be located in Barangay Mahabang Parang, Batangas City;

## DISCUSSIONS AND OBSERVATIONS:

During the discussion, the following observations was raised:

1. City Environment Certificate from the City Environment and Natural Resources (CEC) and National Water Regulatory Board (NWRB) Certificate has not been secured by the company;

2. Documentation of the Barangay Public Hearing was not submitted to the August Body;

3. The submitted Tax Declarations of the property is classified under Agricultural;

4. Impact Assessment, Planning and Mitigation Measures does not include Mechanical;

5. Thermal and Electrical impact;

6. Consumers will have to shoulder the additional charges once the facility is utilized but Price Matrix per Khr/m is not provided;

7. The Budget indicated in the submitted document does not reflect the actual project cost.

#### CONCLUSION:

In view of the foregoing, the committee hereby adopts the recommendations of the City Planning and Development Office in its Evaluation Report on the subject as integral part of this Committee Report copy of which is attached herewith as Annex A.

The Universal Power Solution, Inc. Shall secure National Water Regulatory Board (NWRB) Certificate in addition to the recommendations of the CPDO.

Non compliance with the provisions and conditions stipulated herein shall be sufficient ground or basis for revocation of the issuance of this decision.

The project proponent submitted the following additional documentation to to the committee in compliance to the aforementioned directives: Proof of Barangay Public Hearing held last August 1, 2022; Reclassification of the Subject Properties from Agricultural to Industrial; Corporate Social Responsibility Program; Total Project Cost (Annex B).

UPSI provided justification for the following issues:

Structural Analysis; Price Matrix Per kWh; Water Source and NWRB (Annex B)

#### II. SITE DESCRIPTION

- The site of the proposed project will be located on the western portion of the substation of the National Grid Corporation of the Philippines (NGCP) in Barangay Mahabang Parang, Batangas City.
- 2. The project will primarily be composed of a Battery Energy Storage System (BESS) which could support the integration of variable renewable energy sources such as wind and solar to the grid and will also provide ancillary services to NGCP such as frequency relocation, help improve the stability and reliability of the transmission system.

#### III. EVALUATION OF FACTS

- 1. The abovementioned project site is within the designated Industrial-1 Mixed-Use Zone (I1MX-Z) as per the Batangas City Integrated Zoning Ordinance CY 2019.
- 2. The Barangay Council of Mahabang Parang passed Barangay Resolution No. 22 Series of 2021 on October 29, 2021 approving and interposing no objection to the construction and development of Universal Power Solutions Inc. for the Integrated Renewable Power Facility Hub in Barangay Mahabang Parang, Batangas City".
- The Punong Barangay of Brgy. Mahabang Parang, Batangas City issued a Barangay Clearance dated May 6, 2022 for the construction of the Integrated Renewable Power Facility Hub project.
- 4. The project through its proponent was granted an Environmental Compliance Certificate ECC-OL-R4A-2021-0453 issued on September 7, 2021 by EMB-DENR.
- 5. The project facilities/components shall include the following:
  - 5.1 Housed in 3x40 ft containers complete with battery and battery racks

5.2 DC fused switch panel

- 5.3 Building Application Power Board
- 5.4 HVAC- Heating, Ventilation and Air Conditioning

5.5 Fire-Fighting and Control System

- 3.6 Main Power Transformer
- 3.7 Station Power Transformer
- 5.8 Converter Transformer
- 5.9 Auxiliary Transformer
- 5.10 Line Protection System
- 3.11 SKID and Surge
- 5.12 Emergency Generator Set
- 5.13 Switch tard and Interconnection Facility
- 5.14 200KW Solar Panel and 100KW Wind Turbine

## IV.CONDITIONS

This evaluation report with reference to the standard requirements submitted to the Zoning Division of the City Planning and Development Office regarding the application for zoning locations? clearance of Universal Power Solution Inc. for its proposed Integrated Renewable Power Facility Hub project in Barangay Mahabang Parang, this city is being submitted with the endorsement of the Honorable City Mayor to the Sangguniang Panlungsod for appropriate action but not limited to the following considerations:

1. The proponent shall comply with the provisions of City Ordinance No. 8 Series of 1994, otherwise known as "Providing Priority in Employment or Work to Qualified Barangay Residents";

- The proponent shall comply with all the applicable provisions of the Batangas City Environment Code of CY 2010 (City Ordinance No. 16 Series of 2010);
- The proponent shall secure the required City Environmental Certificate from the City Environment and Natural Resources Office (City ENRO) prior to the start of the proposed project;
- 4. The proponent shall provide areas for greening and buffer zone along the entire periphery of the project site in compliance to the provisions of the Environmental Compliance Certificate issued for the project;
- 5. The proponent shall require all the contractors and sub-contractors to secure the necessary permits and clearances from the city government prior to the conduct of any activity within the project site;
- 6. The proponent shall allow at any reasonable time even without prior notice, authorized city government officials/employees with proper IDs to conduct monitoring and inspection of the ongoing activities being undertaken within the project site;
- 7. The proponent shall ensure the prevention of siltation and earth filling/deposits within and along all creeks and other waterways within the entire project site through sound and proper cugincering interventions;
- The proponent shall comply with the applicable provisions of Clean Water Act of 2004 or RA 9275, the Clean Air Act of 1999 or RA 8749 and Solid Waste Management Act of 2000 or RA 9003;
- 9. The proponent shall provide adequate parking spaces within the project site.
- The proponent shall implement all the standard mitigating measures to minimize dust emission, ruisance and other forms of emission during the conduct of all activities related to the construction and operation of the project;
- The proponent shall be held responsible for any project activity that will endanger the general welfare, safety and health of all its workers and residents of the host and adjacent barangays;
- The proponent shall strictly observe all the standard health and safety protocols set by the National Inter-Agency Task Force on the Management and Prevention of Emerging Infectious Diseases and the Batangas City Government particularly the prevention and mitigation of the transmission of COVID 19 at the work place;
- Any valid complaint against the activities being undertaken at the project site shall be sufficient cause for the revocation of the clearance issued to the proponent and shall be the basis of concerned government agencies to order termination or stoppage of all the activities being conducted within the project site;
- The applicable requirements of all other concerned national and city government agencies and applicable provisions of the existing laws and city ordinances shall be complied with, and
- Any misrepresentation, false statement or allegation material to the issuance of this decision shall be sufficient ground or basis for its revocation.
