**APPROVING AND DECLARING OPERATIVE THE 2022 SANGGUNIANG
KABATAAN SUPPLEMENTAL BUDGETS OF DIFFERENT BARANGAYS OF
BATANGAS CITY**

WHEREAS, a judicious review, evaluation and analysis of each of the Sangguniang Kabataan Supplemental Budgets submitted to the Sangguniang Panlungsod shows substantial compliance with law and all budgetary rules and regulations.

NOW THEREFORE, be it resolved, as it hereby resolves, to approve and declare operative the Sangguniang Kabataan Supplemental Budgets for the purpose the amounts were appropriated:

APPROVING AND DECLARING OPERATIVE THE 2022 SANGGUNIANG KABATAAN SUPPLEMENTAL BUDGETS OF DIFFERENT BARANGAYS OF BATANGAS CITY
