**RESOLUTION NO. 22-323 S. 2022**

**A RESOLUTION APPROVING THE ACCREDITATION OF BARAKO GATORS  
SWIMMING TEAM, INC.**

**WHEREAS**, presented before the Sangguniang Panlungsod, were papers of **BARAKO GATORS SWIMMING TEAM, INC.** for accreditation purposes;

**WHEREAS**, in adherence to the Local Government Code of 1991 as reiterated below, the following provisions were elucidated among the representatives of **BARAKO GATORS SWIMMING TEAM, INC.** during the committee hearing held on September 30, 2022 at the Sangguniang Panlungsod Session Hall that were attended by the members of the said committee and other members of the Council.

1. Chapter 4. - Relations with People’s and Non-governmental Organizations.
  - 1.1 Section 34. Role of People’s and Non-governmental Organizations. - Local Government Units shall promote the establishment and operation of peoples and non-governmental organizations to become active partners in the pursuit of local autonomy.
  - 1.2 Section 35. Linkages with People’s and Non-governmental Organizations. - Local Government Units may enter into joint ventures and such other cooperative arrangements with people's and non-governmental organizations to engage in the delivery of certain basic services, capability-building and

livelihood projects, and to develop local enterprises designed to improve productivity and income, diversify agriculture, spur rural industrialization, promote ecological balance, and enhance the economic and social well-being of the people.

- 1.3 Section 36. Assistance to People’s and Non-governmental Organizations. - A Local Government Unit may, through its local chief executive and with the concurrence of the Sanggunian concerned, provide assistance, financial or otherwise for economic, socially-oriented, environmental or cultural projects to be implemented within its territorial jurisdiction.

**WHEREAS**, the Committee on Accreditation of the Sangguniang Panlungsod has scrutinized the papers of **BARAKO GATORS SWIMMING TEAM, INC.** in order to find out whether this NGO is qualified for accreditation and membership in the Local Special Bodies;

**WHEREAS**, the Sangguniang Panlungsod thru the Committee on Accreditation has approved the accreditation of **BARAKO GATORS SWIMMING TEAM, INC.** as accredited NGO in the Sangguniang Panlungsod, after having found to have complied with all the necessary requirements for this purpose.

**NOW THEREFORE**, be it resolved as it is hereby resolved by the Sangguniang Panlungsod in session assembled to approve, as it hereby approves, the application for Accreditation of **BARAKO GATORS SWIMMING TEAM, INC.** in the City of Batangas.

**RESOLVED FURTHER**, that all documents attached hereto made integral parts of this resolution and that copies of this resolution be furnished to **BARAKO GATORS SWIMMING TEAM, INC.** for their guidance and information.



#### COMMITTEE REPORT

SUBJECT: Application for Accreditation of

- Pilipinas Shell Foundation, Inc.
- Malalim Multi-Purpose Cooperative
- Gulod-Dumantay Batangas City Transport Cooperative
- Apex Club of Batangas City
- Apex Womens Club of Batangas City
- Barako Gators Swimming Team Inc.
- Community Based Support System (CBSS)

The Committee called a Committee Hearing for the purpose of evaluating the qualifications of the applicant for accreditation, and to reiterate the provisions of the Local Government Code and its Implementing Rules and Regulations and to provide other clarificatory guidelines relative to the accreditation of people's organizations, non-governmental organizations and other organized groups, and in the selection of their representatives to the local special bodies.

The committee hearing was held on September 30, 2022, 9:00am at the Sangguniang Panlungsod, Session Hall. Present during the committee hearing were: the Chairman of the Committee on Accreditation, Hon. Nelson J. Chavez and Members, Hon. Nestor E. Dimacuha, Michael C. Villena and Hon. Isidra M. Atienza. Also present were the Sangguniang Panlungsod Presiding Officer, Hon. Atty. Alyssa Renee A. Cruz, Hon. Andrea Loise F. Macaraig, Hon. Jose Jonash Luis F. Tolentino, Hon. Lorenzo A. Gamboa Jr. and Hon. Oliver Z. Macatangay. The representatives of the applicant - Pilipinas Shell Foundation, Inc. Ms. Olivia Mamisay Sorio, Malalim Multi-Purpose Cooperative Mr. Pastor E. Cleofe, Gulod-Dumantay Batangas City Transport Cooperative Mr. Bernardo C. Cueto. Apex Club of Batangas City Mr. Nelson P. Perez, Apex Womens Club of Batangas City Ms. Lorna D. Palo, Barako Gators Swimming Team Inc. Ms. Shiela Coliyat and Community Based Support System (CBSS) Mr. Rufino Gonda.

The committee hearing revolved around the accreditation of people's organization, non-governmental organizations and similar aggrupations, which focused on the coverage, purpose, accreditation process and requirements and other related guidelines. The committee finds that the applicant substantially complied with the requirements of the law for accreditation except Community Based Support System (CBSS) that meet all the requirements except the Certificate of Registration from any NGA (or in the case of IPOs, certification issued by NCIP).

The committee hereby recommends:

1. The adoption of this committee report; and
2. The approval of the resolution hereto attached
