**A RESOLUTION APPROVING THE ACCREDITATION OF ONE PILIPINAS

**WHEREAS**, presented before the Sangguniang Panlungsod, were papers of **ONE PILIPINAS GUARDIANS BROTHERHOOD INCORPORATED (1PGBI) ALA - EH - BATANGAS CITY CHAPTER** for accreditation purposes;

**WHEREAS**, in adherence to the Local Government Code of 1991 as reiterated below, the following provisions were elucidated among the representatives of **ONE PILIPINAS GUARDIANS BROTHERHOOD INCORPORATED (1PGBI) ALA - EH - BATANGAS CITY CHAPTER** during the committee hearing held on October 11, 2022 at the Sangguniang Panlungsod Session Hall that were attended by the members of the said committee and other members of the Council;

1. Chapter 4. - Relations with People’s and Non-governmental Organizations.
  - 1.1 Section 34. Role of People’s and Non-governmental Organizations. - Local Government Units shall promote the establishment and operation of people’s and non-governmental organizations to become active partners in the pursuit of local autonomy.
  - 1.2 Section 35. Linkages with People’s and Non-governmental Organizations. - Local Government Units may enter into joint ventures and such other

cooperative arrangements with people's and non-governmental organizations to engage in the delivery of certain basic services, capability-building and livelihood projects, and to develop local enterprises designed to improve productivity and income, diversify agriculture, spur rural industrialization, promote ecological balance, and enhance the economic and social well-being of the people.

- 1.3 Section 36. Assistance to people's and Non-governmental Organizations. - A Local Government Unit may, through its local chief executive and with the concurrence of the Sanggunian concerned, provide assistance, financial or otherwise for economic, socially-oriented, environmental or cultural projects to be implemented within its territorial jurisdiction.

**WHEREAS**, the Committee on Accreditation of the Sangguniang Panlungsod has scrutinized the papers of **ONE PILIPINAS GUARDIANS BROTHERHOOD INCORPORATED (1PGBI) ALA - EH - BATANGAS CITY CHAPTER** in order to find out whether this NGO is qualified for accreditation and membership in the Local Special Bodies;

**WHEREAS**, the Sangguniang Panlungsod thru the Committee on Accreditation has approved the accreditation of **ONE PILIPINAS GUARDIANS BROTHERHOOD INCORPORATED (1PGBI) ALA - EH - BATANGAS CITY CHAPTER** as accredited NGO in the Sangguniang Panlungsod, after having found to have complied with all the necessary requirements for this purpose.

**NOW THEREFORE**, be it resolved as it is hereby resolved by the Sangguniang Panlungsod in session assembled to approve, as it hereby approves, the application for Accreditation of **ONE PILIPINAS GUARDIANS BROTHERHOOD INCORPORATED (1PGBI) ALA - EH - BATANGAS CITY CHAPTER** in the City of Batangas.

**RESOLVED FURTHER**, that all documents attached hereto made integral parts of this resolution and that copies of this resolution be furnished to **ONE PILIPINAS GUARDIANS BROTHERHOOD INCORPORATED (1PGBI) ALA - EH - BATANGAS CITY CHAPTER** for their guidance and information.



#### COMMITTEE REPORT

& THE HONORABLE SANGGUNIANG PANLUNGSOD MEMBERS**

SUBJECT: Application for Accreditation of

- Batangas Filipino Chinese Chamber of Commerce Inc.
- Sta. Clara Transport Service Cooperative
- One Pilipinas Guardians Brotherhood Incorporated (1PGBI) Ala – Eh – Batangas City Chapter
- PARDSS Foundation International Inc. Batangas
- Batangas City Council of Batangas Varsitarian 1932, Inc.

The Committee called a Committee Hearing for the purpose of evaluating the qualifications of the applicant for accreditation, and to reiterate the provisions of the Local Government Code and its Implementing Rules and Regulations and to provide other clarificatory guidelines relative to the accreditation of people's organizations, non-governmental organizations and other organized groups, and in the selection of their representatives to the local special bodies.

The committee hearing was held on October 11, 2022, 9:30am at the Sangguniang Panlungsod, Session Hall. Present during the committee hearing were: the Chairman of the Committee on Accreditation, Hon. Nelson J. Chavez and Members, Hon. Nestor E. Dimacuja and Michael C. Villena. Also present were Hon. Andrea Loise F. Macaraig, Lorenzo A. Gamboa Jr., Hon. Angelito "Dondon" A. Dimacuja, and Hon. Marjorie A. Manalo SK Federation President. The representatives of the applicant - Batangas Filipino Chinese Chamber of Commerce Inc. Willy Wong, Sta. Clara Transport Service Cooperative Aristotle Atienza, One Pilipinas Guardians Brotherhood Incorporated (1PGBI) Ala – Eh – Batangas City Chapter Eden Real, PARDSS Foundation International Inc. Batangas Ricky Anonuevo and Batangas City Council of Batangas Varsitarian 1932, Inc. Kristian Ian Chavez.

The committee hearing revolved around the accreditation of people's organization, non-governmental organizations and similar aggrupations, which focused on the coverage, purpose, accreditation process and requirements and other related guidelines. The committee finds that the applicant substantially complied with the requirements of the law for accreditation.

2. The approval of the resolution hereto attached




