RESOLUTION REQUESTING THE HONORABLE CITY MAYOR BEVERLEY ROSE A. DIMACUHA THROUGH THE HR DEPARTMENT TO ASSIGN SIGN LANGUAGE INTERPRETERS IN ALL DEPARTMENTS AND OFFICES IN THE CITY GOVERNMENT OF BATANGAS

WHEREAS, Section 2 (e) of the Republic Act 7277, Magna Carta of Disabled Persons, states its principle "To facilitate integration of disabled persons into the mainstream of society, the State shall exert all efforts to remove social, cultural, economic, environmental and attitudinal barriers that are prejudicial to disabled persons;

WHEREAS, Sign Language Interpreter as specialist provides interpreting, translation, and transliteration services and other visual and tactual communication forms used by individuals who are Deaf, Hard-of-Hearing, and Deaf-Blind;

WHEREAS, Sign Language is an extremely important communication tool for many deaf and hard-of-hearing people which provides full access to communication using hand gestures and movements, body language and facial expressions, instead of spoken words;

WHEREAS, Signing is not only practiced primarily by the deaf and hard-of-hearing but it is also used by hearing individuals, such as those who are unable to physically speak, those who have trouble with oral language due to a disability or condition, and those with deaf family members including children of deaf adults;

NOW THEREFORE, RESOLVED as it is hereby resolved by the Sangguniang Panlungsod in session assembled, to request the Hon. City Mayor Beverley Rose A. Dimacuha through the HR Department to assign Sign Language Interpreters in all Departments and Offices in the City Government of Batangas that will aid to promote communication for individuals who are Deaf and Hard-of-Hearing.
