**WHEREAS**, the Philippine Statistics Authority (PSA) shall primarily be responsible for all national censuses and surveys, sectoral statistics, community-based statistics, consolidation of selected administrative recording systems, and compilation of national accounts;

**WHEREAS**, the Community-Based Monitoring System under the Philippine Statistics Authority is currently ongoing in the City of Batangas;

**WHEREAS**, the correction between the boundary of Barangay Pallocan Silangan and Barangay Pallocan Kanluran was respectfully corrected during the Committee Hearing;

**WHEREAS**, Mr. Rodolfo Vergara from the Philippine Statistics Authority (PSA) remarked that the correction will happen during the data processing procedure after the CBMS Enumeration;

**WHEREAS**, necessary documents must be submitted and attached herewith to comply with the requirements for the correction of the Philippine Statistics Authority (PSA);

**THE COMMITTEE ON PUBLIC LANDS**  
**COMMITTEE REPORT**

***CORRECTION OF BOUNDARY BETWEEN BRGY. PALLOCAN EAST AND BRGY. PALLOCAN WEST; AND BRGY. MAAPAZ AND BRGY. PAHARANG EAST***

**BACKGROUND:**

The subject is regarding the correction of boundary between Pallocan East and Pallocan West and was referred to the Committee on Public Lands for its consideration during the Regular Session on August 23, 2022. The Committee held a hearing on September 28, 2022 and in attendance were the following:

The Committee on Public Lands Chairman, Hon. Michael Villena, and its members namely, Hon. Hamilton Blanco and Hon. Andrea Macaraig. Also present were the Sangguniang Panlungsod Members namely, City Vice Mayor Atty. Alyssa Cruz, and City Councilors: Hon. Karlos Buted, Hon. Nestor Dimacuha, Hon. Oliver Macatangay, Hon. Nelson Chavez, Hon. Armando Lazarte, Hon. Jonash Tolentino, Hon. Zester Hernandez, Hon. Isidra Atienza, and Hon. Lorenzo Gamboa, Jr. The guests were also present such as Barangay Captains of the barangays concerned namely, Mr. Garry Panopio of Pallocan East and their Barangay Council, Mr. Vlademir Arellano of Maapaz, and Mr. Marcelo Evangelio of Paharang East. Meanwhile, Barangay Kagawad Adrian Macatangay from Pallocan West is also present to represent their barangay. Also present during the hearing were Mr. Rodolfo Vergara from Philippine Statistics Authority – Batangas, Mr. Neil Pargas from the Registry of Deeds, Mr. Raul Buenafe from the City Assessor's Office, and Engr. Edgar Festijo from the City Planning and Development Office.

**FINDINGS:**

The Chairman of the Committee on Public Lands, the members of the Committee, and the Members of the Sangguniang Panlungsod extensively made an overview of the subject and suggested necessary matters:

1. Mr. Raul Buenafe from the City Assessor's Office reiterated that there is no big problem on the subject matter because the first step called enumeration is the data gathering procedure only;
2. As probed by the committee to Mr. Rodolfo Vergara, the representative from Philippine Statistics Authority, that the most vital way to resolve the matter is to wait for the data processing, which is the next step on the ongoing Community-Based Monitoring System (CBMS) Enumeration;
3. Meanwhile, it is also stated that the issue is not on the boundaries, but solely on the place of residency;

In conclusion, the necessary documents must be prepared for the adjustment of the subject matter in order for it to be addressed immediately.

**RECOMMENDATIONS:**



In view of the foregoing, the Committee hereby recommends:

1. The adoption of this Committee Report;
2. The approval of the Resolution hereto attached.
