RESOLUTION NO. 22-365 S. 2022

**A RESOLUTION APPROVING THE ACCREDITATION OF ILIJAN
DEVELOPMENT FOUNDATION, INC.**

WHEREAS, presented before the Sangguniang Panlungsod, were papers of **ILIJAN DEVELOPMENT FOUNDATION, INC.** for accreditation purposes;

WHEREAS, in adherence to the Local Government Code of 1991 as reiterated below, the following provisions were elucidated among the representatives of **ILIJAN DEVELOPMENT FOUNDATION, INC.** during the committee hearing held on October 18, 2022 at the Sangguniang Panlungsod Session Hall that were attended by the members of the said committee and other members of the Council.

Chapter 4. - Relations with People’s and Non-governmental Organizations.

- 1.1 Section 34. Role of People’s and Non-governmental Organizations. - Local Government Units shall promote the establishment and operation of people’s and non-governmental organizations to become active partners in the pursuit of local autonomy.
- 1.2 Section 35. Linkages with People’s and Non-governmental Organizations. - Local Government Units may enter into joint ventures and such other cooperative arrangements with people’s and non-governmental organizations to engage in the delivery of certain basic services, capability-building and livelihood projects, and to develop local enterprises designed to improve

productivity and income, diversify agriculture, spur rural industrialization, promote ecological balance, and enhance the economic and social well-being of the people.

- 1.3 Section 36. Assistance to People's and Non-governmental Organizations. - A Local Government Unit may, through its local chief executive and with the concurrence of the Sanggunian concerned, provide assistance, financial or otherwise for economic, socially-oriented, environmental or cultural projects to be implemented within its territorial jurisdiction.

WHEREAS, the Committee on Accreditation of the Sangguniang Panlungsod has scrutinized the papers of **ILIJAN DEVELOPMENT FOUNDATION, INC.** in order to find out whether this NGO is qualified for accreditation and membership in the Local Special Bodies;

WHEREAS, the Sangguniang Panlungsod thru the Committee on Accreditation has approved the accreditation of **ILIJAN DEVELOPMENT FOUNDATION, INC.** as accredited NGO in the Sangguniang Panlungsod, after having found to have complied with all the necessary requirements for this purpose.

NOW THEREFORE, be it resolved as it is hereby resolved by the Sangguniang Panlungsod in session assembled to approve, as it hereby approves, the application for Accreditation of **ILIJAN DEVELOPMENT FOUNDATION, INC.** in the City of Batangas.

RESOLVED FURTHER, that all documents attached hereto made integral parts of this resolution and that copies of this resolution be furnished to **ILIJAN DEVELOPMENT FOUNDATION, INC.** for their guidance and information.



COMMITTEE REPORT

TO: **THE HONORABLE VICE MAYOR ATTY. ALYSSA RENEE A. CRUZ
& THE HONORABLE SANGGUNIANG PANLUNGSOD MEMBERS**

SUBJECT: Application for Accreditation of

- Ilijan Community Development Foundation, Inc.
- Livestock and Poultry Raiser's Association
- Philippine Mental Health Association (PMHA) Lipa - Batangas Chapter
- Rotary Club of Batangas
- Community Investigative Support

The Committee called a Committee Hearing for the purpose of evaluating the qualifications of the applicant for accreditation, and to reiterate the provisions of the Local Government Code and its Implementing Rules and Regulations and to provide other clarificatory guidelines relative to the accreditation of people's organizations, non-governmental organizations and other organized groups, and in the selection of their representatives to the local special bodies.

The committee hearing was held on October 18, 2022, 11:00am at the Sangguniang Panlungsod, Session Hall. Present during the committee hearing were: the Chairman of the Committee on Accreditation, Hon. Nelson J. Chavez and Members, Isidra "Ched" M. Atienza, Hon. Nestor E. Dimacuha, and Michael C. Villena. Also present were the Honorable Presiding Officer Hon. Atty. Alyssa Renee A. Cruz, Hon. Hamilton G. Blanco, Hon. Andrea Loise F. Macaraig, Hon. Karlos Emmanjuel A. Buted, Hon. Oliver Z. Macatangay, Hon. Jose Jonash Luis F. Tolentino, Hon. Zester Carlos M. Hernandez, Hon. Lorenzo A. Gamboa Jr., and Hon. Marjorie A. Manalo SK Federation President. The representatives of the applicant - Ilijan Community Development Foundation, Inc. Ramon C. Andal Vice Chairperson and Ruby B. Mendoza Executive Director, Livestock and Poultry Raiser's Association Moises C. Dalisay President, Philippine Mental Health Association (PMHA) Lipa - Batangas Chapter Dr. Normando B. Napeñas Chapter Chairperson and Hazel Magpantay Chapter Executive Manager, Rotary Club of Batangas Arnel L. Pulla Genuine Service President and Community Investigative Support Nerio T. Manalo Batangas Chapter President.

The committee hearing revolved around the accreditation of people's organization, non-governmental organizations and similar aggrupations, which focused on the coverage, purpose, accreditation process and requirements and other related guidelines. The committee finds that the applicant substantially complied with the requirements of the law for accreditation except Rotary Club of Batangas that meet all the criteria under Items 4.3.1.2 to 4.3.1.4 of Memorandum Circular No. 2022-083, and pass all the requirements stated in Items 4.2.3.1 to 4.2.3.8, except the Certificate of Registration or existing valid Certificate of Accreditation from Any NGA (or in the case of IPOs, certification issued by NCIP).

Meanwhile Bantay ng Karagatan ng Lungsod ng Batangas which was heard last September 8, 2022 that meet all the criteria under Items 4.3.1.2 to 4.3.1.4 of Memorandum Circular No. 2022-083, and pass all the requirements stated in Items 4.2.3.1 to 4.2.3.8, except the Certificate of Registration or existing valid Certificate of Accreditation from Any NGA (or in the case of IPOs, certification issued by NCIP).

The committee hereby recommends:

1. The adoption of this committee report; and
2. The approval of the resolution hereto attached


