**APPROVING AND DECLARING OPERATIVE THE 2022 SANGGUNIANG
KABATAAN SUPPLEMENTAL BUDGETS OF BARANGAY POBLACION 02 AND
POBLACION 09, BOTH OF BATANGAS CITY**

WHEREAS, a judicious review, evaluation and analysis of the Sangguniang Kabataan Supplemental Budgets of Barangay Poblacion 02 and Poblacion 09, both of Batangas City submitted to the Sangguniang Panlungsod shows substantial compliance with law and all budgetary rules and regulations.

NOW THEREFORE, be it resolved, as it hereby resolves, to approve and declare operative the Sangguniang Kabataan Supplemental Budgets of Barangay Poblacion 02 and Poblacion 09, both of Batangas City for the purpose the amounts were appropriated:


