RESOLUTION NO. 22-373 S. 2022

**A RESOLUTION APPROVING THE REVERSION OF THE CONTINUING
APPROPRIATION UNDER 20% DEVELOPMENT FUND OF THE CITY
GOVERNMENT OF BATANGAS**

WHEREAS, Section 458 of the Local Government Code declares that the Sangguniang Panlungsod, as the legislative body of the city, shall review and appropriate funds for the general welfare of the city and its inhabitants;

WHEREAS, on October 17, 2022, the Honorable City Mayor Beverley Rose A. Dimacuha requested for the reversion of the continuing appropriation under the 20% Development Fund amounting to **ONE HUNDRED SEVENTY-THREE MILLION, ONE HUNDRED FIFTY-NINE THOUSAND, THREE HUNDRED NINETY-SEVEN PESOS AND 41/100 (PHP 173,159,397.41)**;

WHEREAS, the subject matter shall be used as a source of fund by the City Government of Batangas for future Supplemental Budgets;

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, BY THE SANGGUNIANG PANLUNGSOD IN SESSION ASSEMBLED, to approve the reversion of the continuing appropriation under the 20% Development Fund of the City Government of Batangas.


