## A RESOLUTION APPROVING THE ACCREDITATION OF TULO MULTI-PURPOSE COOPERATIVE

WHEREAS, presented before the Sangguniang Panlungsod, were papers of TULO MULTI-PURPOSE COOPERATIVE for accreditation purposes;

WHEREAS, in adherence to the Local Government Code of 1991 as reiterated below, the following provisions were elucidated among the representatives of TULO MULTI-PURPOSE COOPERATIVE during the committee hearing held on November 8, 2022 at the Sangguniang Panlungsod Session Hall that were attended by the members of the said committee and other members of the Council.

1. Chapter 4. - Relations with People's and Non-governmental Organizations.

- 1.1 Section 34. Role of People's and Non-governmental Organizations. Local Government Units shall promote the establishment and operation of people's and non-governmental organizations to become active partners in the pursuit of local autonomy.
- 1.2 Section 35. Linkages with People's and Non-governmental Organizations. -Local Government Units may enter into joint ventures and such other cooperative arrangements with people's and non-governmental organizations to engage in the delivery of certain basic services, capability-building and
