1. Chapter 4. - Relations with People's and Non-governmental Organizations.

- 1.1 Section 34. Role of People's and Non-governmental Organizations. Local Government Units shall promote the establishment and operation of people's and non-governmental organizations to become active partners in the pursuit of local autonomy.
- 1.2 Section 35. Linkages with People's and Non-governmental Organizations. -Local Government Units may enter into joint ventures and such other cooperative arrangements with people's and non-governmental organizations
