WHEREAS, the Department of Health (DOH) issued Administrative Order No. 2016-0038 entitled “The Philippine Health Agenda 2016-2022” which seeks to fulfill the global call for Universal Health Coverage adopting “All for Health Towards Health for All” as the rallying point to realize the vision of a Healthy Philippines by 2022;

WHEREAS, the General Appropriation Act of 2022 or Republic Act 11639 provided for the construction, upgrading, expansion, repair and rehabilitation of Local Government Unit (LGU) Health Care Facilities including the purchase of equipment under the Health Facilities Enhancement Program (HFEP) of the DOH in alignment with “Ambisyon Natin 2040” and the Philippine Development Plan 2017 -2022;

WHEREAS, Department of Health thru the Health Facilities Enhancement Program for CY 2022 has appropriated the amount of Four Million Four Hundred Fifty-Five Thousand Pesos only (Php 4,455,000.00) intended for the New Construction of Barangay Health Stations of San Antonio, Isla Verde, Haligue Kanluran and Talahib Payapa, all of Batangas City;

WHEREAS, each Barangay shall receive the divided total amount of One Million Four Hundred Eighty-Five Thousand Pesos Only (Php 1,485,000.00) to be implemented and procured by the Local Government Unit of the City of Batangas thru transfer of fund;

NOW, THEREFORE, BE IT RESOLVED, as it is hereby resolved by the Sangguniang Panlungsod Members in a Regular Meeting assembled to grant authority for the City Mayor Beverley Rose A. Dimacuha to enter into a Memorandum of Agreement (MOA) with the Department of Health - Center for Health Development Region IV-A CALABARZON regarding the appropriation of funds by the Department of Health thru the Health Facility Enhancement Program (HFEP) under the General Appropriation Act of 2022 for the new construction and upgrading infrastructure and equipment of Health Care Facilities of the Local Government Unit of the City of Batangas.

DISCUSSIONS AND OBSERVATIONS

The following observations resulted after extensive discussions and deliberations of all present during the Committee Hearing, to wit:


1. The Department of Health has a standard measurements and design with regards to the construction of Barangay Health Stations that should be complied with for the issuance of Permit to Operate from the Department of Health;
2. According to the estimate of of the City Engineer's Office, the allocated amount of One Million Four Hundred Eighty Five Thousand Pesos Only (Php1,485,000.00) for the construction of Barangay Health Station in Barangay Talahib Payapa, Barangay Haligue Kanluran and San Antonio, ^{11/23/22}all of Batangas City will not be enough;
3. It is recommended that the project be included in the AIP of the City of Batangas so that the LGU can provide budget for the completion of the project, should funding proves inadequate to finish construction of the above mentioned Barangay Health Stations;

RECOMMENDATIONS


In accordance to the proceedings and based on the observations by the Joint Committee, the Committee on Ways and Means and Committee on Health propose following recommendations:


1. The adoption of this Committee Report; and
2. The approval of the Resolution hereto attached.


