**APPROVING AND DECLARING OPERATIVE THE SUPPLEMENTAL BUDGET FOR
CY 2022 OF BARANGAY SAN AGUSTIN SILANGAN, ISLA VERDE,
BATANGAS CITY**

WHEREAS, a review of the Supplemental Budget for Calendar Year 2022 of Barangay San Agustin Silangan, Isla Verde, Batangas City shows substantial compliance with the provisions of the Local Government Code of 1991.

NOW THEREFORE, be it resolved, as it hereby resolves, to approve and declare operative the Supplemental Budget of Barangay San Agustin Silangan, Isla Verde, Batangas City for Calendar Year 2022 for the purpose the amount was appropriated:
