A RESOLUTION EARNESTLY URGING THE CITY PLANNING AND DEVELOPMENT OFFICE (CPDO) TO ACCOMMODATE THE REQUEST OF BARANGAY DUMUCLAY REGARDING THE COMMUNITY-BASED MONITORING SYSTEM (CBMS) REPORTS THAT SIZEABLE PORTIONS OF SITIO SILANGAN AND SITIO IBABA WERE TRANSFERRED AND NOW MADE PARTS OF BARANGAY TALUMPOK KANLURAN AND CONDE LABAC, RESPECTIVELY; AND ALL BARANGAYS IN THE CITY OF BATANGAS WHO ARE IN THE SAME SITUATION AND PREDICAMENT ANENT THE CORRECT ENUMERATION

WHEREAS, the Philippine Statistics Authority (PSA) shall primarily be responsible for all national censuses and surveys, sectoral statistics, community-based statistics, consolidation of selected administrative recording systems, and compilation of national accounts;

WHEREAS, the Community-Based Monitoring System under the Philippine Statistics Authority is currently ongoing in the City of Batangas through the City Planning and Development Office (CPDO);

WHEREAS, the CBMS Team reported that counterparts from Brgy. Talumpok Kanluran had clearly taken the needed data, at least taking the left side of the road eastward to known boundary with Brgy. Talumpok Kanluran;

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED BY THE SANGGUNIANG PANLUNGSOD IN SESSION ASSEMBLED, to earnestly urge the City Planning and Development Office (CPDO) to accommodate the request of Barangay Dumuclay regarding the Community-Based Monitoring System (CBMS) reports that sizeable portions of Sitio Silangan and Sitio Ibaba were transferred and now made parts of Barangay Talumpok Kanluran and Conde Labac, respectively; and all barangays in the City of Batangas who are in the same situation and predicament anent the correct enumeration.
