WHEREAS, the Philippine Statistics Authority (PSA) shall primarily be responsible for all national censuses and surveys, sectoral statistics, community-based statistics, consolidation of selected administrative recording systems, and compilation of national accounts;

WHEREAS, the Community-Based Monitoring System under the Philippine Statistics Authority is currently ongoing in the City of Batangas;

WHEREAS, the correction among the enumeration of Barangays Maapaz, Paharang East, and San Jose Sico was respectfully corrected during the Committee Hearing;

WHEREAS, Mr. Rodolfo Vergara from the Philippine Statistics Authority (PSA) remarked that the correction will happen during the data processing procedure after the CBMS Enumeration;
