Sir/Mesdames:

Considering the urgency and not to delay and hamper the delivery of service to the City Government and its Constituency, the Committee convened on November 18, 2022 at exactly 9:00am to meticulously discuss the aforementioned subject.

Present during the hearing are the Chairman of the Committee on Laws, Rules, and Regulations, Hon. Coun. Nestor E. Dimacuha and Members, Hon. Coun. Isidra M. Atienza, Hon. Coun. Karlos Emmanjuel A. Buted, and Hon. Coun. Nelson J. Chavez. Also present were the Sangguniang Panlungsod Presiding Officer, Hon. Vice Mayor Atty. Alyssa Renee A. Cruz, Hon. Coun. Andrea Loise F. Macaraig, Hon. Coun. Oliver Z. Macatangay, Hon. Coun. Lorenzo A. Gamboa Jr., and Hon. Coun. Michael C. Villena. Invited guests present during the hearing include Ms. Maribel Perez, Mr. Ruel Saonoy — President of Nino Jesus Security Services Corporation, Ms, Luciana Delos Santos of AGP Sales & Building Services, Mr. Rustico P. Morelos & Mr. Rudy Cariaga of World Cup Security Services Inc., Ms. Arlene Magadia of RBC Petron Gasoline Station, Mr. Jeric Pardo of SB Hain Enterprises & General Services Inc., Ms. Jocelyn Cantre of GSD, Mr. Manolo M. Perlada of City Budget Office, and Atty. Teodolfo Deguito of City Legal Office.

Moving forward, the Committee without hesitations requested all the Contractors / Service Providers involved with the City Government of Batangas to express their willingness for possible extension of their Contracts. Several issues anent the Contractors Statutory Obligations were raised which should be religiously applied, provided, and extended to their workers or employees in compliance with PD 442 Labor Code of the Philippines, Book 3, Title 1, Article 83-88 and RA 11058 otherwise known as "An Act Strengthening Compliance with Occupational Safety and Health Standards (OSHS) and Providing Penalties for Violations thereof." Meanwhile, Ms. Joyce Cantre of GSD emphasized the Revised IRR of RA 9184 otherwise known as the "Government Procurement Reform Act" anent the importance of early procurement to ensure implementation of government projects, services, and missions in a timely, economical and efficient manner. Mr. Manolo Perlada however discussed the obligated funds intended for the services under the Annual Budget for FY 2023 which was concurred by Atty. Teodolfo Deguito of the City Legal Office. After the enlightenment, Contractors collectively manifest the tacit indications of their assertiveness of accepting the request of the City Mayor for the possible extension of their Contracts.

On that premise, the Committee finds the merit of the request valid and therefore recommends the following:
