**APPROVING AND DECLARING OPERATIVE THE 2023 SANGGUNIANG
KABATAAN ANNUAL BUDGETS OF BARANGAY POBLACION 23 AND BARANGAY
KUMINTANG IBABA, BOTH OF BATANGAS CITY**

WHEREAS, a judicious review, evaluation and analysis of each of the Sangguniang Kabataan Annual Budgets for CY 2023 submitted to the Sangguniang Panlungsod shows substantial compliance with law and all budgetary rules and regulations.

NOW THEREFORE, be it resolved as it hereby resolves, to approve and declare operative the following Sangguniang Kabataan Annual Budgets for Calendar Year 2023 to wit:
