# A RESOLUTION GRANTING AUTHORITY TO THE CITY MAYOR BEVERLEY ROSE A. DIMACUHA TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH LAND BANK OF THE PHILIPPINES, UNION BANK OF THE PHILIPPINES AND DEVELOPMENT BANK OF THE PHILIPPINES TO UTILIZE THEIR ONLINE COLLECTION FACILITY

WHEREAS, the Batangas City Government, pursuant to the provisions of Republic Act No. 8792, otherwise known as the "Electronic Commerce Act of 2000", is currently undertaking the modernization of its facility to provide fast and efficient alternative payment collection service to its clientele;

WHEREAS, the Land Bank of the Philippines, Union Bank of the Philippines and Development Bank of the Philippines have facilities designed to allow partner-merchants' to directly transact with the bank's payment gateway or allow partner-merchant to directly interface with their payment gateway, whichever is available;

WHEREAS, clients may transact business and/or pay their monetary obligation to Batangas City Government via the internet using any of the ePayment models being offered by the Land Bank of the Philippines, Union Bank of the Philippines and Development Bank of the Philippines, and subject to the terms and conditions appurtenant thereto;

WHEREAS, Batangas City Government agrees to enter into direct agreement with the aforementioned banks to avail of their ePayment models as applicable;

WHEREAS, the City Mayor requests for authority to enter into Memorandum of Agreement with the aforementioned banks to utilize their online collection facility;

After the prayer led by Councilor Karlos Emmanjuel Buted, the Committee Hearing commenced.

#### DISCUSSIONS AND OBSERVATIONS:

During the discussion, the following observations was raised:

1. Ms. Arminda Madayag, OIC City Treasurer gave a background and over view of the subject matter. According to her, Batangas City has an existing collection services and for further collection efficiency, the Batangas City Government's needs a fast and alternative payment collection service, there is a need to seek cooperation with different banks with ePayment facilities such us Land Bank of the Philippines, Union Bank of the Philippines and Development Bank of the Philippines;

2. This will also provide ease and convenience for Batangas City Government's tax payers;

3. Transaction within the same bank will have no charges, but there will be a

2% charge when using others;

4. Disadvantage is in the reconciliation with the accounting, and there will be additional work for the City Governments, but because its digital age, comfort will be provided to the clientele. This will reduce delinquency, specially to those payers who are out of town or out of the country;

5. There is a problem with reconciliation using Maya and G-Cash because of the

lack of information provided;

6. Convenience Fee is not included in the Revenue Code;

7. If there is a problem with G-Cash and Maya, Development Bank of the Philippines will be accountable because there is an existing MOA with Maya, DBP and the Batangas City Government and untoward incidents are isolated

8. The payers do not need to have a Maya or G-Cash App to avail of the online facility. It is suggested to have a pop up message informing the same in any

portal:

9. Even if the existing collection services caters to all, payers prefer to use their

own banks to transact;

10. Legally, there will be no problem, but there will be benefits because avenues

for payment will be expanded within the bounds of the law.

11. Since 2020 the system is working and there is no untoward incidents since but to increase efficiency, it a suggested to compare statistics with regards to data analysis for further improvement of the system
