WITH UNIONBANK**

**WHEREAS**, the Local Government of Batangas is continuously undertaking the modernization of its facility to provide fast and efficient alternative payment collection services to its constituents;

**WHEREAS**, in compliance with Republic Act No. 11032 or the Ease of Doing Business and Efficient Government Service Delivery Act of 2018, the Local Government aims to establish effective practices and efficient turnaround of the delivery of government services through business one-stop-shop for business and license permit application and renewal, construction permits, tax payments, as well as to provide easy and accessible payment options to its constituents;

**WHEREAS**, the Local Government intends to bring about more efficient and effective payment and collection services for transacting constituents through an electronic payment and collection system allowing the government to better manage the financial resources and improving revenue generation capability;

**WHEREAS**, UnionBank offers collection services to the Local Government to help achieve the foregoing purpose;

**WHEREAS**, there is a need to authorize the Honorable City Mayor to execute and sign the Collection Services Agreement and other related agreements with UnionBank for the latter to render the service;
