WHEREAS, the DILG Batangas in coordination with other agencies, is mandated to develop the capacities of LGUs to transform them into self-reliant communities in line with the principles of decentralization and local autonomy;

WHEREAS, the DILG Batangas in coordination with other agencies, is committed to carry out its responsibility of strengthening the management and technical competencies of local officials and functionaries by providing them access in local governance and wealth of knowledge;

WHEREAS, the DILG Batangas in coordination with other agencies, is committed to sustain its effort of developing LGU capacities through sharing of knowledge, learning and experience as well as replication of good practices in local government;

WHEREAS, the DILG Batangas has chosen Batangas City as one of LGUs in the region as a DILG Batangas City Sub-LGRC to be housed in Batangas City Library and Information Center;

WHEREAS, the DILG Batangas and the Local Government Unit of Batangas City, Batangas agree to jointly pool knowledge and expertise on local government;

WHEREAS, the City Mayor requested for the grant of authority to sign a Memorandum of Agreement with the Department of the Interior and Local Government for the purpose;

NOW THEREFORE, be it resolved, as it is hereby resolved by the Sangguniang Panlungsod in session assembled, to grant authority to the City Mayor, Honorable Beverley Rose A. Dimacuha to sign a Memorandum of Agreement with the Department of the Interior and Local Government (DILG) Batangas, represented by Provincial Director Abigail N. Andres, CESO V.
