**RESOLUTION AUTHORIZING THE CITY MAYOR BEVERLEY ROSE A.  
DIMACUHA TO GRANT THE GRATUITY PAY FOR THE FISCAL YEAR 2022 TO  
CONTRACT OF SERVICE AND JOB ORDER WORKERS OF THE  
CITY GOVERNMENT OF BATANGAS**

**WHEREAS**, His Excellency President Ferdinand “Bongbong” R. Marcos, Jr. issued Administrative Order No. 03 dated 23 December 2022 authorizing the grant of Gratuity Pay to Contract of Service (COS) and Job Order (JO) workers in Government for Fiscal Year 2022 in the amount not exceeding Five Thousand Pesos (Php 5,000.00);

**WHEREAS**, AO No. 03 states that granting a year-end Gratuity Pay to COS and JO workers is a well-deserved recognition of their hard work in implementing programs, projects, and activities, and pivotal role in the delivery of government services amidst the ongoing COVID-19 pandemic and present socio-economic challenges;

**WHEREAS**, Section 5 of AO No. 03 enjoins Local Government Units (LGUs) to adopt in their respective offices the grant of Gratuity Pay to workers whose services are engaged through COS and JO, utilizing appropriate and available funding sources, and that corresponding supplemental budget shall be enacted by the respective Sanggunian within FY 2022;

**WHEREAS**, the City Mayor, through the City Budget Officer, certifies the availability of fund for the Gratuity Pay to Batangas City Government Contract of Service and Job Order workers;
